**PLEASE NOTE:** The pricing options above applies to standard residential properties (E.g. three to four bedroom, single dwelling premises) allowing for an inspection time of up to 1.5 hours. For larger properties, e.g. farms, industrial and commercial premises, mansions, guest houses, etc, our fees will be charged at R595.00 per hour or part thereof for upfront payment (R685.00 per hour for payment on transfer). For inspections of properties outside of the general Cape Town area (Peninsula), an additional travel cost may apply.

If we are asked to attend to only one inspection (E.g. only the beetle inspection), our minimum call-out fee of R680.00 applies and the inspection fee must be settled upfront. The option of payment on transfer is not available. Our call-out fee (minimum charge) for maintenance or repairs is R680.00 including VAT.
